Street Survival - MC- we are not having a September street survival. PCA would like to co-sponsor next Spring's event. Doug Barlett working through PCA to possibly get the Dick's Sporting Goods lot. Janet will work to see if the 6th and Kipling location to see if that could be a location.

DS Updates - Reserved for May 23-24, 2015 booked for next year. Fall will be Saturday, September 5th at Pueblo.

Autocross - Last event is this Saturday with 73 people registered. Brief recap of attendance. AX banquet is October 26th at Lamar Street Center in Arvada. Michael was approached by the Vail Vintage Club concours organizers who want to run an autocross next year around the time of their event. They will be attending our Planning meeting to discuss details.

Autocross Trailer looks fantastic, will be at the event this weekend for the first time. In October we'll discuss the advertising and sponsorship details- what do people get when they pay and participate. We will need to ensure advertisers are providing graphics that are consistent with our branding approach. More details will be determined at a later date.

CR/TT - Possible NASA Date - We need to determine whether we want to proceed with the pre-existing event on October 11th-12th. So long as we aren't responsible for providing minimum numbers. MC- feels we're too close to this event timing, would recommend we move forward with this next year instead of this next month. BG agrees, let's use the winter to formalize how this works including some mentor materials and determine how we want to partner with NASA or other clubs. AJ- we may be able to partner with other clubs, such as the Monty Car Club who have less numbers. In this scenario, this would be our event and would need determine insurance. GB will look into possible dates for next year.

As for Club Racing, National recommends building up our TT program and then channel that into Club Racing, so National is indeed supportive of our endeavors. So at this point, no Club Race next year.
